

### Introduction and statement

The Watkin Jones Group (WJG) is wholly committed to providing a workplace and culture that supports a zerotolerance approach to modern slavery. We act ethically and with integrity in all our business dealings and relationships and implement effective systems and controls to ensure modern slavery is not taking place anywhere in our own business or in supply chains. In accordance with the requirements of the Modern Slavery Act 2025.

#### **Organisational structure**

WJG is a UK-based Company in the construction, property development and facilities management sector. It is the parent company of the Group and employs circa 615 people throughout the UK, supported by some 1,500 subcontracted workers and has business operations in the UK and Republic of Ireland.

### Our business and supply chain

To acquire sites, agree financial investment and construct/develop state of the art properties and manage properties, we work with a range of suppliers including building materials suppliers, cleaning, security, fittings and furnishings, trade services such as electrical, plumbing and site management. In addition, the Company may on occasion engage with third party employers and sub-contractors for labour support.

### **Our policies and procedures**

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chain or any part of our business. We strive to act in an ethical manner with respect to all our suppliers to endorse the same high standards in their dealings with us.

We maintain a comprehensive range of policies designed to ensure our compliance with various legal and regulatory obligations, these include Anti-Corruption and Bribery, Anti-Slavery and Human Trafficking, Whistleblowing and H&S policies.

The compliance officers within the WJG; Miles Littlewood H&S and Environmental Director Watkin Jones and Graham Pawson Property Services Director Fresh, have primary and day-to-day responsibilities for implementing policies, monitoring use and effectiveness, dealing with any queries and auditing internal control systems and procedures to ensure they are effective in countering modern slavery.

# Combating slavery and human trafficking and identifying any risks

WJG regularly evaluates the nature and extent of its exposure to the risk of modern slavery occurring in our supply chain by undertaking a detailed supply chain evaluation which adopts a thorough and intensive pre-selection process. WJG ensures that each supplier or subcontractor is fully aware of the requirements to achieve Supply Chain Partner status. A detailed database of approved suppliers and subcontractors is maintained, and new firms can only be added once quality, safety, environmental and financial checks have been carried out.

#### **Due Diligence processes**

We operate in construction and the property management sectors in the UK and Republic of Ireland. All employees, sub-contractors or third-party labour are appointed directly or via approved agencies. In all instances right to work checks are carried out (both for UK and Republic of Ireland). All our materials, fixtures and fittings are provided by supply chain partners who have fulfilled the requirements of the detailed evaluation and pre-selection process.

Where we have identified a potential risk, we conduct regular audits / site visits and where issues arise, we may consider ceasing to use the specific supplier.

As part of our efforts to monitor and reduce the risk of slavery and human trafficking occurring within our supply chains, we have adopted the following due diligence procedures:

- Step 1 Detailed supply chain evaluation
- Step 2 Detailed and accurate procurement process
- Step 3 Selection of appropriate subcontractors and suppliers
- Step 4 On site quality control
- Step 5 Development review on project completion
- Step 6 Quality through continuous improvement

Our procedures are designed to:

- establish and assess areas of potential risk in our business and supply chains
- monitor potential risk areas in our business and supply chains
- reduce the risk of slavery and human trafficking occurring in our business and supply chains
- provide adequate protection for whistleblowers

We ensure all our suppliers adhere to our Anti-slavery and Human Trafficking policy. We enforce a strict code of compliance and do not tolerate slavery and human trafficking within our supply chains. If we find evidence of a failure to comply with our policies, we will immediately seek to terminate our relationship with the relevant supplier.

Management at all levels are responsible for ensuring those reporting to them understand and comply with this policy and are given adequate and regular training on it and the issue of modern slavery in supply chains.

# **Further Steps**

Following our review of our actions this financial year to prevent slavery or human trafficking from occurring in our business or supply chains, we are satisfied that there are no current risks and as such no actions are required.

This statement is made in accordance with section 54(1) of the Modern Slavery Act 2015 and constitutes Watkin Jones Group's slavery and human trafficking statement for the financial year commencing 2024 and ending 2025. This statement was approved by the Board in April 2025
